

**SUMMARY ANNUAL REPORT FOR
AMERICAN SENIOR COMMUNITIES, L.L.C. MASTER WELFARE PLAN**

This is a summary of the annual report of the American Senior Communities, LLC Master Welfare Plan (Employer Identification Number 35-2077389, Plan Number 501) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

American Senior Communities, L.L.C. has committed itself to pay certain medical, prescription drug claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with The Lincoln National Life Insurance Company, Metropolitan Life Insurance Company, Anthem Insurance Companies, Inc., Continental American Insurance Company And Sun Life Assurance Company Of Canada to pay certain Life insurance, VOLUNTARY ACCIDENTAL DEATH & DISMEMBERMENT, Long-term disability, Temporary disability, WEEKLY INCOME, Vision, Dental, CRITICAL CARE & ACCIDENT, Stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$5,861,805.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$8,044,380 as of the end of plan year, compared to \$9,447,486 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of - \$1,403,106. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$37,672,720 including employer contributions of \$24,478,025, employee contributions of \$12,749,130, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$384,432. Plan expenses were \$39,075,826. These expenses included \$2,332,337 in administrative expenses, \$36,743,489 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
