

**SUMMARY ANNUAL REPORT FOR  
AMERICAN SENIOR COMMUNITIES, L.L.C. MASTER WELFARE PLAN**

This is a summary of the annual report of the American Senior Communities, L.L.C. Master Welfare Plan (Employer Identification Number 35-2077389, Plan Number 501) for the plan year 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

American Senior Communities, L.L.C. has committed itself to pay certain medical, prescription drug claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with The Lincoln National Life Insurance Company, Delta Dental Of Indiana, Continental American Insurance Company And Sun Life Assurance Company Of Canada to pay certain Life insurance, VOLUNTARY ACCIDENTAL DEATH & DISMEMBERMENT, Long-term disability, Temporary disability, WEEKLY INCOME, Vision, Dental, CRITICAL CARE & ACCIDENT, Stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$6,226,478.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$1,281,390 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$0.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$6,101,325 as of the end of plan year, compared to \$8,044,380 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$1,943,055. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$42,352,757 including employer contributions of \$27,969,999, employee contributions of \$14,038,180, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$283,921. Plan expenses were \$44,295,812. These expenses included \$2,555,587 in administrative expenses, \$41,740,225 in benefits paid to participants and beneficiaries, and \$0 in other expenses.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
