Your Qualified Default Investment Alternative

Your Plan includes a Qualified Default Investment Alternative (QDIA), which has been established in accordance with section 404(c)(5) of ERISA and other legal regulations. Under this provision, unless you make an affirmative election with respect to your investment options, the Plan will automatically invest any amounts in the default investment alternative that has been established for your Plan. You have the right to transfer your investment in the default investment alternative to any other available investment alternative under the Plan by logging into your account at **transamerica.com/portal/ascretire**.

Unless you choose otherwise, your account will be invested in the QDIA, PIMCO RealPath Blend Institutional Funds series, which is a group of single target date funds based on your assumed retirement age of 65.
